# "DR-2XE Installation Support Program" Procedures & Terms and Conditions

#### **Procedures:**

## For customers who purchase a new DR-2XE:

- 1. Complete the Application Form after the installation/ purchase of a new DR-2XE.
- 2. Submit the Application Form to the YAESU authorized distributors or dealers from whom you purchase the new DR-2XE.
- 3. YAESU authorized distributors handle the "DR-2XE Installation Support Program." Please ask YAESU authorized distributors or local dealers, for any detailed benefits of the program.

## For customers who purchase a new DR-2XE and trade-in the existing DR-1XE:

- 1. Complete the Application Form after the installation/ purchase of a new DR-2XE.
- 2. Submit the Application Form to the YAESU authorized distributors or dealers from whom you purchase the new DR-2XE.
- 3. YAESU authorized distributors handle the "DR-2XE Installation Support Program." Please ask YAESU authorized distributors or local dealers, for any detailed benefits of the program for your purchase of the new DR-2XE.
- 4. If "trade-in" is selected, make sure with dealers from whom you purchase a new DR-2XE to which of YAESU authorized distributors you should contact and ship your existing DR-1XE for "trade-in."
- 5. Within 30 days after installation of a new DR-2XE, ship your DR-1XE to the YAESU authorized distributor by insured carrier. It is highly recommended that you contact the YAESU authorized distributor before you ship the existing DR-1XE. Shipping cost must be incurred by customers.
- 6. YAESU authorized distributor shall confirm the appearance and operation of your DR-1XE. When they confirm that your DR-1XE is in reasonable condition for "trade-in," your DR-1XE shall be transferred to Yaesu UK Ltd. When not, YAESU authorized distributor may return your DR-1XE to you.
- 7. Yaesu UK Ltd. shall reconfirm the condition of your DR-1XE. After the confirmation, Yaesu UK Ltd. arranges the payment of EUR300/ GBP270 to your bank account. Payment shall be processed 6 to 8 weeks after receiving your DR-1XE by Yaesu UK Ltd.

#### **Terms and Conditions:**

- 1. "DR-2XE Installation Support Program" is valid from January 1, 2018 to June 30, 2018.
- 2. "DR-2XE Installation Support Program" is valid for customers who purchase a brand new DR-2XE (CE model) from the YAESU authorized distributors or dealers in Europe and UK ONLY.
- 3. If "trade-in" is selected, amount of cashback for returned DR-1XE is EUR300/ GBP270.
- 4. If "trade-in" is selected, customers must return an existing DR-1XE to the YAESU authorized distributors within 30 days after the purchase of a new DR-2XE.
- 5. Shipping Cost must be incurred by customers.
- 6. If "trade-in" is selected, payment method of cashback is electronic transfer to customers' bank account. Payment shall be processed 6 to 8 weeks after receiving customers' DR-1XE by Yaesu UK Ltd.
- 7. Yaesu UK Ltd. shall not be liable for any VAT, Bank or Building Society processing or administration fee associated with this program.
- 8. "Trade-in" offer (cashback) may be void where taxed, restricted or prohibited by local country regulations.
- YAESU authorized distributors and YAESU UK Ltd. shall decline to accept the return of customers' DR-1XE when the DR-1XE has been modified, altered, tampered, or abused; is damaged by inadequate packing or shipping procedures; or incorrect information is provided in the Application Form
